In the event the Indiana State Fairgrounds or any part of the exhibit area thereof is unavailable whether for the entire event, or a portion of the event as a result of flood, fire, tempest, or any other such cause or as a result of governmental intervention, malicious damage, acts of war, strike, lock-out, labor dispute, riot, or any other cause or agency over which WCGS, INC. has no control, or should WCGS, Inc. decide that because of any such cause it is deemed necessary to cancel, postpone, or re-site the event, World Class Gun Shows, Inc. shall not be liable to indemnify or reimburse the exhibitor in respect of any damage or loss, direct or indirect, arising as a result thereof.

WCGS, Inc. shall have full power in the interpretation and enforcement of contract regulations and rules and the power to make such amendments thereto, and such further rules and regulations as shall be considered necessary for proper conduct of the event.
